CHIEF EXECUTIVE OFFICER'S REPORT

A. Operations Report

Chief Executive Officer Rashidi Barnes acknowledged the new City of Antioch board members and expressed appreciation for them serving on ECCTA's board.

Mr. Barnes gave an update on two potential funding scenarios for the regional measures. Mr. Barnes gave a brief overview of the history of the legislative efforts made in the last year. These two funding scenarios will be polled in January. The select committee will still determine the duration of the measure as well as the funding mechanism. The geography selected to participate will most likely be four counties. The presentation of the findings from the poll will be in February.

Mr. Barnes announced that ECCTA was awarded a grant to be applied to our electric bus chargers and will help update the technology.

Mr. Barnes acknowledged Robert Harrison for his 24 years of service and congratulated him on his retirement as IT Specialist. Michael Delphin was announced as the new IT Administrator. Mr. Barnes also announced that Tania Babcock will be departing from ECCTA. Supervisor Federal Glover was acknowledged for his 23 years of service to Contra Costa County and congratulated on his retirement. Directors Adams, Williams, Scales-Preston, Oerlemans, Higgins, Rocha, Shaw, and Freitas all shared gratitude and appreciation for Supervisor Glover and all of his tremendous work in Contra Costa County. Chair Burgis sent a video expressing her gratitude and a video was shown with additional interviews reflecting on his amazing work.

ACTION ITEM AND DISCUSSION ITEMS

A. Revised DBE Triennial Goal for FFY's 2023-2025

Compliance Manager Tania Babcock presented the DBE program. The regulations require ECCTA to set a triennial DBE goal. Ms. Babcock reviewed the methodology and due dates required by this regulation. Due to the use of federal funding, the construction of the hydrogen fueling station and the improvements of ECCTA's bus charging stations required an amendment to the triennial goal, setting it to 1%. It was confirmed that this change had no fiscal impact.

On motion by Director Williams, seconded by Director Scales-Preston, the board of directors approved resolution #241211A accepting ECCTA's revised DBE triennial goal of one percent (1%) for FTA-assisted contracts for FFY's 2023-2025 and authorizing staff to submit the goal to the FTA, which was carried by the following vote:

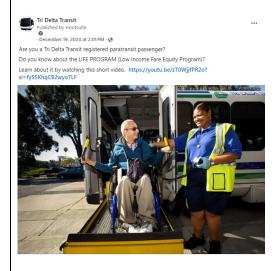

Re: December Activity Report

Politico Group is pleased to provide the following report to the East Bay Small Operators Transit Coalition (Coalition) on state legislative, budget, and ballot measure activity in December. There was limited activity in December following the swearing in of members on December 2, but the Legislature will return to Sacramento next week with the Governor's special session and the forthcoming state budget proposal at the top of the agenda for January. The report below discusses new committee assignments in the Assembly, which were announced in late December, as well as forthcoming actions on the state budget and the Governor's special session to prepare for litigation against the federal government.

2025-2026 Legislative Session Begins

Legislative Leaders Re-Elected - New Assembly Committee Chairs

The new California State Legislature was sworn in for the 2025-2026 session on Monday, December 2 in Sacramento. With election results now final in each county, Democrats will retain legislative supermajorities, controlling 75% of the seats in both the Assembly and the Senate despite slight Republican gains. Governor Newsom has called special elections to fill two vacancies created by a Senator's resignation and an Assemblymember's election to Congress. The primaries for those safe Republican districts will be held in February, with the special elections falling on April 29.

Senate President pro Tempore Mike McGuire (D-Healdsburg) and Assembly Speaker Robert Rivas (D-Hollister) were both re-elected to their leadership positions on the first day of session. In late December, Speaker Rivas announced changes to committee chairmanships and his leadership team for the new session. The Assembly fiscal and policy committees most relevant to the Coalition will retain the same leaders in 2025, with Assemblymember Lori Wilson (D-Suisun) chairing the Transportation Committee and Assemblymember Steve Bennett (D-Ventura) chairing Assembly Budget Subcommittee No. 4 on Climate Crisis, Resources, Energy and Transportation.

In addition to Chair Wilson's leadership of the Transportation Committee, the Coalition's other Assembly delegation members will continue in their committee leadership roles:

- Assemblymember Rebecca Bauer-Kahan Chair, Privacy and Consumer Protection Committee
- Assemblymember Liz Ortega Chair, Labor and Employment Committee
- Assemblymember Buffy Wicks Chair, Appropriations Committee

Pro Tem McGuire has yet to announce new committee chairs for the Senate, where much more significant changes will take place following the departure of the Senators who chaired six powerful

committees in 2024, including the committees on Energy, Utilities & Communications; Governmental Organization; Health; Housing; Revenue & Taxation; and Education. Following announcements of committee chairs, both leaders will appoint members to all policy and budget committees in early 2025.

State Budget Update and Special Session

Preparing for the New Federal Administration – 1st Extraordinary Session & State Budget

Following the convening of the regular legislative session in early December, both houses convened for the 1st Extraordinary Session over objections from Republicans. Governor Newsom called the Legislature into this special session to appropriate funding for California to take both preemptive and reactive legal action against potential policies from the incoming Trump Administration. Assembly Budget Committee Chair Jesse Gabriel introduced two special session budget bills that would appropriate a total of \$25.5 million to the Department of Justice for anticipated state litigation costs. These two bills adhere closely to the narrow proclamation issued by Governor Newsom, but the Senate is pursuing a broader strategy.

Senate Budget and Fiscal Review Chair Scott Wiener has introduced legislation that, in addition to \$25 million for state litigation costs, would provide \$10 million in funding for grants to local government civil prosecutors to "protect reproductive health, environmental justice, LGBTQ civil rights, immigrant rights, or other vulnerable communities in California." Senator Wiener's SBx1-1 would also provide \$25 million to legal aid groups to support vulnerable persons at risk of detention, deportation, eviction, wage theft, intimate partner violence, and to represent Californians in deportation proceedings. It's currently unclear whether the Assembly will be open to these additional measures, but the Governor has asked the Legislature to send him special session bills prior to Inauguration Day on January 20.

In related budget news, Governor Newsom's 2025-26 state budget proposal is due to the Legislature by the constitutional deadline of January 10. The December Bulletin from the Department of Finance showed that California's personal income tax and corporation tax receipts were below budget estimates for the month of November, but still ahead of cumulative estimates since April by \$4.9 billion and \$755 million, respectively. Sales tax revenues, however, continue to lag estimates by \$708 million since April. Despite the relatively positive revenue performance, the Legislative Analyst's Office has projected a roughly balanced budget with an approximately \$2 billion deficit for 2025-26. Updated revenue projections will be included in the Governor's budget in January.

CEQA also requires a lead agency to prepare a mitigated negative declaration for a project that may have a significant effect on the environment if revisions in the project would avoid or mitigate that effect and there is no substantial evidence that the project, as revised, would have a significant effect on the environment. This bill would provide for limited CEQA review of an application for a discretionary permit or authorization for a clean hydrogen transportation project, as defined, by requiring the application to be reviewed through a clean hydrogen environmental assessment, unless otherwise requested by the applicant, as prescribed. The bill would, except as provided, require the lead agency to determine whether to approve the clean hydrogen environmental assessment and issue a discretionary permit or authorization for the project no later than 270 days after the application for the project is deemed complete.

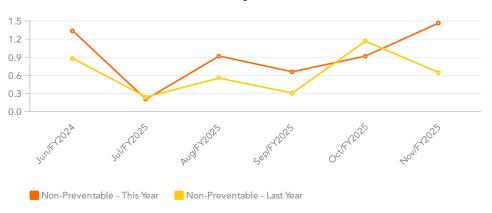

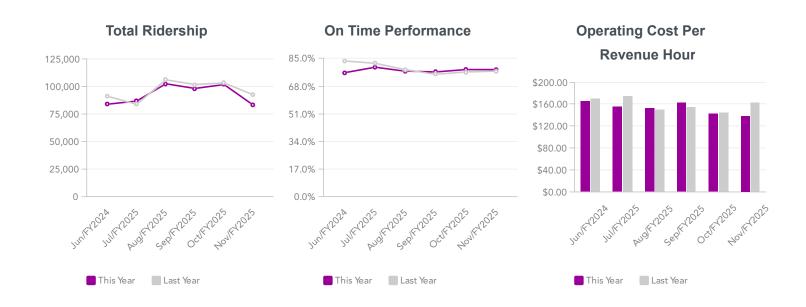

Non-Preventable Accidents Per 100,000 Miles Last Six Months - System Wide

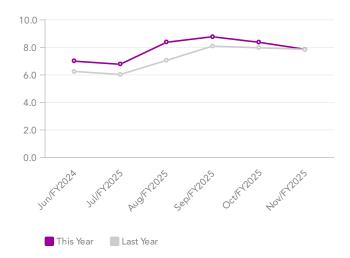

Passengers Per Revenue Hour





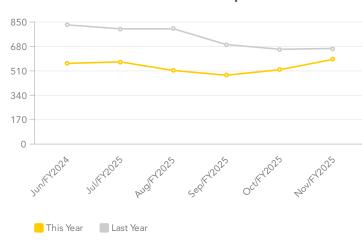

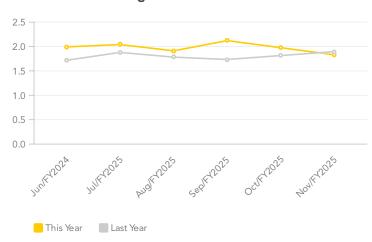

Passengers Per Revenue Hour



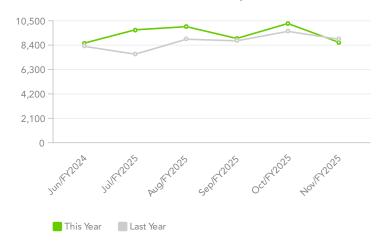

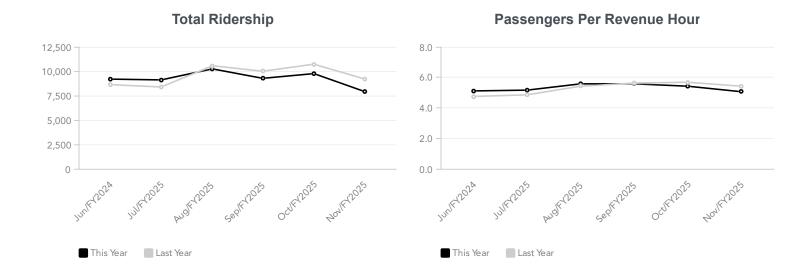

Background

On June 26, 2024, the Board of Directors adopted a balanced budget for the Fiscal Year (FY) 2024-2025. Budget planning intends to resource and allocate the available funding for the period covered and, if possible, to address future economic contingencies. The expectation of the mid-year budget adjustments will address changing conditions unknown from the budget adoption period and adjust for anticipated economic trends.

Transit agencies across the Bay Area continue to face mounting short- and long-term budgetary challenges. The emergence of online retail has introduced uncertainty for local sales tax projections, which impacts Measure J and X funding. Deferred maintenance of aging infrastructure looms on the horizon, and instability at all levels of funding sources will undermine both longstanding and new local funding sources. ECCTA is not immune to these or other financial challenges and makes best efforts to build better financial sustainability to withstand impacts.

Discussion

The mid-year analysis below addresses the operating funds for FY2024-2025. The total revenues and expenditures budget adopted for the FY2024-2025 was \$35.5 million.

General Operating Revenues:

There are some changes in the external funding sources based on actual allocation received from each of the external funding agencies and additional external funding sources being allocated to the agency after the adoption of the FY2024-2025 budget.

The agency's sources of revenue are as below:

- 1. **Passenger Fare Revenues**: the agency's passenger fares consist of fares collected from riders. The passenger fares collected through December 31, 2024, were 57% of the budgeted amount, and the agency is projecting an increase of **\$78,300** for the proposed FY2024-2025.
- 2. **Auxiliary Transportation Revenue:** consists of advertising income and sales of regional Transit Connection (RTC) cards. The agency is projecting an increase of **\$8,289** by the end of the fiscal year.
- 3. **Other Agency Revenue:** consists of operating investment interest income and other miscellaneous revenue. The agency is projecting an increase of **\$19,279** by the end of the fiscal year.
- 4. **Bart Feeder Fund:** makes up for 8% of the agency's revenue.
- 5. **Local Funds:** consist of sales tax Measure J and X and RM2 and 3 funds. The agency received lower Measure J allocations than the approved budget.
- 6. **State Funds:** consist of TDA and STA funds. There was adjustment of TDA 4.5 funds as a result of allocation timing difference.
- 7. **Federal Fund:** consist of 5307 ADA operating assistance and 5311 preventive maintenance funds. The 5307 ADA operating assistance was overstated.

Grants were secured during the first half of FY2024-2025 to free up the general operation funding to reduce the budget deficit amounts that the agency began at the start of the fiscal year.

- Received a **\$449,000** grant for upgrading of battery electric charging infrastructure from Bay Area Air Quality Management District Infrastructure Solicitation Program.
- Received \$216,078 of TMR operating assistance fund from the Transportation Fund for Clean Air (TFCA) Projects.
- Received **\$163,759** grant reimbursement for facilities repair work completed two years ago. The initial request was declined; however our grant manager's diligent follow-through with Caltrans resulted in receipt of full reimbursement in October 2024.

Operating Expenditures:

The agency's areas of operating expenditures are as follows:

- 1. Salaries and Benefit expenditures consist of salaries, overtime, paid absences, retirement, and group insurance. These expenditures make up approximately 18% of the agency's total operating budget. The agency is projecting an increase in cost of \$238,047 by the end of the FY2024-2025 due to an increase in health premiums, large amounts of PTO payouts associated with the separation of employees, and Maintenance Department's overtime resulting from staffing shortage.
- 2. Purchase Transportation expenditures consist of contracted vehicle operation services and transportation network company (TNC) services such as Uber, Lyft, and United Medical Transportation. These expenditures make up approximately 60% of the agency's total expenditures. The agency is projecting an increase in the cost of \$94,888 by the end of FY2024-2025 due to an increase in TNC services.
- 3. Other expenditures make up for approximately 22% of the agency's total expenditures and consist of fuel, tires, materials and supplies, outside service, taxes, utilities, and others. The agency is projecting a decrease of \$695,059 by the end of FY2024-2025.

The net changes in General Operating Funds after accounting for the proposed changes to the Revenues and Expenditures show a deficit of \$81,261 by the end of FY2024-2025. The agency's ongoing efforts in securing new grants and cutting costs are expected to lead to a significant reduction of deficit amounts by the end of the fiscal year; the agency started the year with a deficit of \$765,333. This illustrates that the agency is actively identifying areas where spending can be decreased, finding cost-effective alternatives, and strategically allocating funds to maximize value within budget constraints.

Capital Projects Updates:

The Board of Directors approved \$11.5 M in capital projects for the FY 2024-2025. There are no new budget requests for the capital projects in FY2024-2025.

The capital projects status:

- 1. Received 18 new buses; 15 paratransit buses and 3 TMR buses.
- 2. The Hydrogen Fuel Station is still scheduled to be completed by December 31, 2026.

Financial Impact

The acceptance of mid-year budget analysis to the Board of Directors by staff, as outlined above, does not have an immediate financial impact on the agency.

Background

The Metropolitan Transportation Commission (MTC) is responsible for the allocation of the FTA Formula Program funds comprised of Section 5307 Urbanized Area, 5337 State of Good Repair and Section 5339 Bus and Bus Facilities. MTC's Transit Capital Priorities (TCP) process helps ensure that the limited federal transit dollars available go to essential projects. In order to be eligible for these funds, ECCTA must submit a program of essential projects during the TCP call for projects. Projects must be evaluated and meet the screening criteria as part of the TCP process to be funded. The current TCP call for projects covers FY25 through FY29.

Financial Impact

MTC has made allocations from FY25 and FY26 Formula Program funds, which include funding for six ECCTA projects. These projects include:

RESOLUTION #250122B AUTHORIZATION OF FILING FOR FTA FORMULA PROGRAM FUNDS

Resolution #250122B authorizes the filing of an application for FTA Formula Program and Surface Transportation Programs funding for Replace 6 Minivans, Replace 8 25' Cutaways, Replace 5 40' Diesel Buses with FCEB, Hydrogen Fueling Station, Battery Electric Charging Upgrade and ADA Operating Assistance and committing the necessary local match for the project(s) and stating the Assurances of Eastern Contra Costa Transit Authority to complete the project

WHEREAS, the Infrastructure Investment and Jobs Act, or the Bipartisan Infrastructure Law (BIL, Public Law 117-58) continues and establishes new Federal Transit Administration formula programs (23 U.S.C. §53) and continues the Surface Transportation Program (23 U.S.C. § 133); and

WHEREAS, pursuant to BIL, and the regulations promulgated there under, eligible project sponsors wishing to receive Federal Transit Administration (FTA) Section 5307 Urbanized Area, Section 5337 State of Good Repair, or Section 5339 Bus and Bus Facilities (collectively, FTA Formula Program) grants or Surface Transportation Program (STP) grants for a project shall submit an application first with the appropriate metropolitan transportation planning organization (MPO), for review and inclusion in the MPO's Transportation Improvement Program (TIP); and

WHEREAS, the Metropolitan Transportation Commission is the MPO for the San Francisco Bay region; and

WHEREAS, the Eastern Contra Costa Transit Authority (ECCTA) is an eligible project sponsor for FTA Formula Program or STP funds; and

WHEREAS, ECCTA wishes to submit a grant application to MTC for funds from the FY2024-25 and FY2025-26 FTA Formula Program or STP funds, for the following project(s):

- 1) Replace 6 Minivans
- 2) Replace 8 25-ft Cutaways
- 3) Replace 5 40-ft Diesel Buses with Fuel Cell Electric Bus
- 4) Hydrogen Fueling Station
- 5) Battery Electric Charging Upgrade
- 6) ADA Operating Assistance

WHEREAS, MTC requires, as part of the application, a resolution stating the following:

1) the commitment of necessary local matching funds (18-50% for FTA Formula Program funds, depending on project type, and 11.47% for STP funds); and

- 2) that the sponsor understands that the FTA Formula Program and STP funding is fixed at the programmed amount, and therefore any cost increase cannot be expected to be funded from FTA Formula Program or STP funds; and
- 3) the assurance of the sponsor to complete the project as described in the application, and if approved, as programmed in MTC's TIP; and
- 4) that the sponsor understands that FTA Formula Program funds must be obligated within three years of programming and STP funds must be obligated by January 31 of the year that the project is programmed for in the TIP, or the project may be removed from the program.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the ECCTA that ECCTA is authorized to execute and file an application for funding under the FTA Formula Program and/or Surface Transportation Program in the amount of \$12,865,915 for Replace 6 Minivans, Replace 8 25-ft Cutaways, Replace 5 40-ft Diesel Buses with Fuel Cell Electric Bus, Hydrogen Fueling Station, Battery Electric Charging Upgrade and ADA Operating Assistance; and

BE IT FURTHER RESOLVED that the Board of Directors of the ECCTA that by adopting this resolution does hereby state that:

- 1) ECCTA will provide \$11,897,110 in local matching funds; and
- 2) ECCTA understands that the FTA Formula Program and STP funding for the project is fixed at \$12,865,915, and that any cost increases must be funded by the ECCTA from local matching funds, and that ECCTA does not expect any cost increases to be funded with FTA Formula Program and Surface Transportation Program funds; and
- 3) Replace 6 Minivans, Replace 8 25-ft Cutaways, Replace 5 40-ft Diesel Buses with Fuel Cell Electric Bus, Hydrogen Fueling Station, Battery Electric Charging Upgrade and ADA Operating Assistance will be built as described in this resolution and, if approved, for the amount shown in the Metropolitan Transportation Commission (MTC) Transportation Improvement Program (TIP) with obligation occurring within the timeframe established below; and
- 4) The program funds are expected to be obligated by January 31 of the year the project is programmed for in the TIP; and
- 5) ECCTA will comply with FTA requirements and all other applicable Federal, State and Local laws and regulations with respect to the proposed project; and

BE IT FURTHER RESOLVED that ECCTA is an eligible sponsor of projects in the program for FTA Formula Program and STP funds; and

BE IT FURTHER RESOLVED that ECCTA is authorized to submit an application for FTA Formula Program and STP funds for Replace 6 Minivans, Replace 8 25-ft Cutaways, Replace 5 40-ft Diesel Buses with Fuel Cell Electric Bus, Hydrogen Fueling Station, Battery Electric Charging Upgrade and ADA Operating Assistance; and

BE IT FURTHER RESOLVED that there is no legal impediment to ECCTA making applications for FTA Formula Program and STP funds; and

BE IT FURTHER RESOLVED that there is no pending or threatened litigation which might in any way adversely affect the proposed project, or the ability of ECCTA to deliver such project; and

BE IT FURTHER RESOLVED that ECCTA agrees to comply with the requirements of MTC's Transit Coordination Implementation Plan as set forth in MTC Resolution 3866; and

BE IT FURTHER RESOLVED that a copy of this resolution will be transmitted to the MTC prior to MTC programming the FTA Formula Program or Surface Transportation Program funded projects in the Transportation Improvement Program (TIP); and

BE IT FURTHER RESOLVED that the MTC is requested to support the application for the project described in the resolution and to program the project, if approved, in MTC's TIP.

Background

In February 2024, a contract was awarded to Nelson\Nygaard Consulting Associates, Inc. to conduct a Comprehensive Operational Analysis (COA) of ECCTA's overall transit system. The primary purpose of the COA is to address the significant decline in ridership that has not recovered post-COVID despite restoring service to pre-pandemic levels. The scope of work for the COA covers planning, scheduling, outreach, development of various service scenarios, and implementation support of a newly redesigned public transportation mobility network in response to the ever-changing landscape and travel patterns in eastern Contra Costa County.

A kick-off meeting took place on April 18, 2024, with ECCTA staff and the Nelson\Nygaard project management team. The COA will be conducted over a 16-month period, and the recommended service plan for the system redesign will be implemented in the Summer/Fall of 2025.

Discussion

The team has made a lot of progress since the last update in October. We have solicited feedback from the public on the two service alternatives, which include virtual and in-person meetings, social media campaigns, and a project website. ECCTA staff and the project management team from Nelson\Nygaard will present key highlights from public engagement and Tri MyRide evaluation findings. The goal is to have a robust dialogue with the Board on the proposed service alternatives, potential trade-offs, and agreement on the preferred service option.

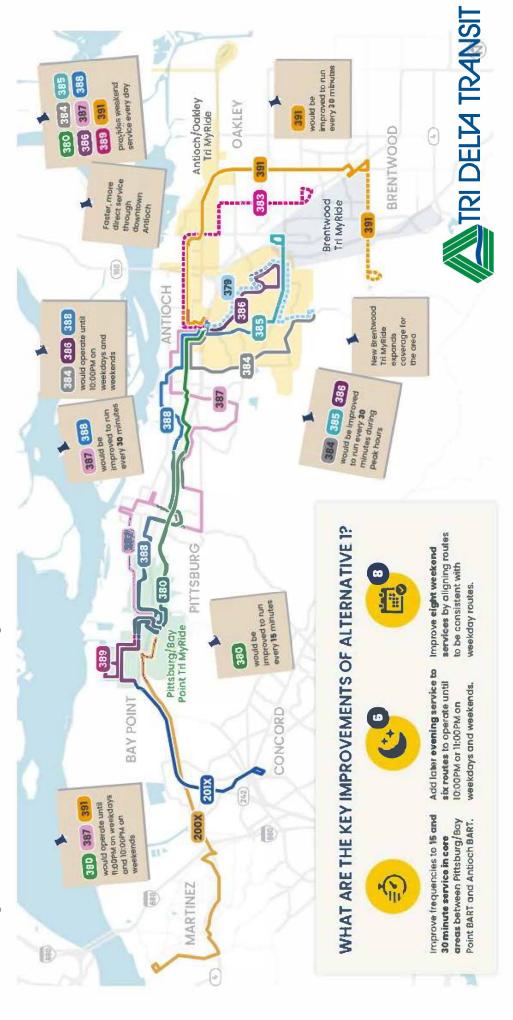

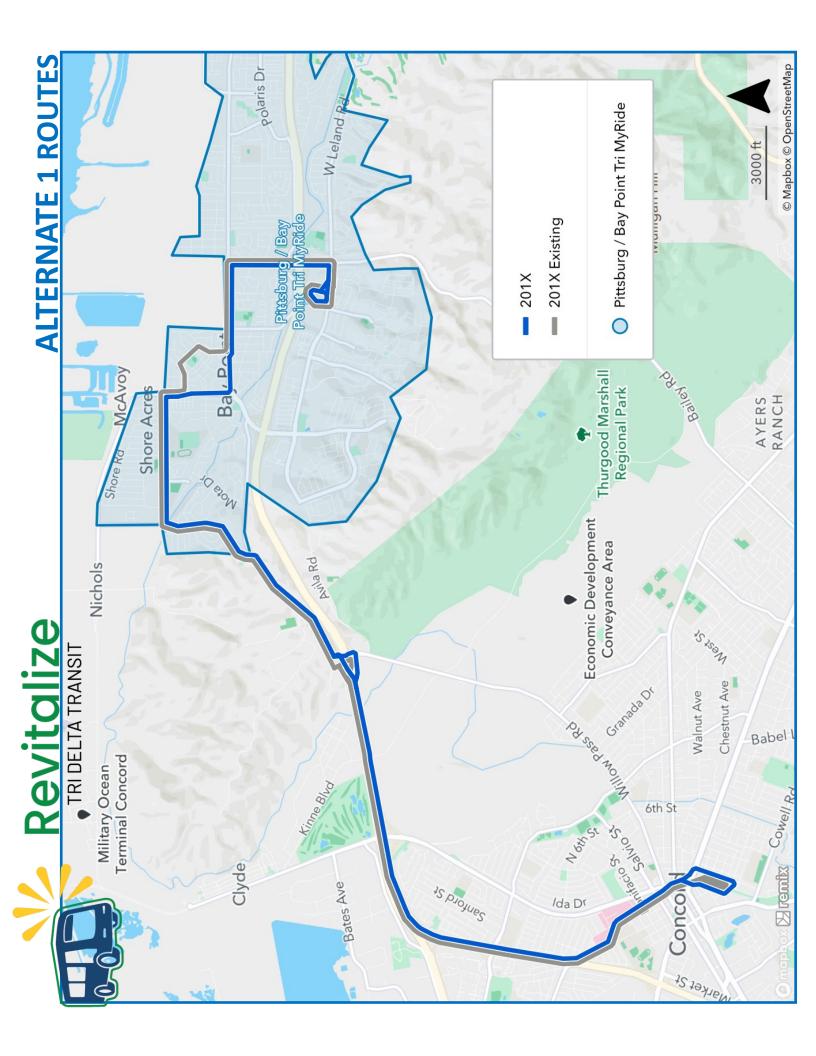

Proposed Service Improvements for Alternative 1

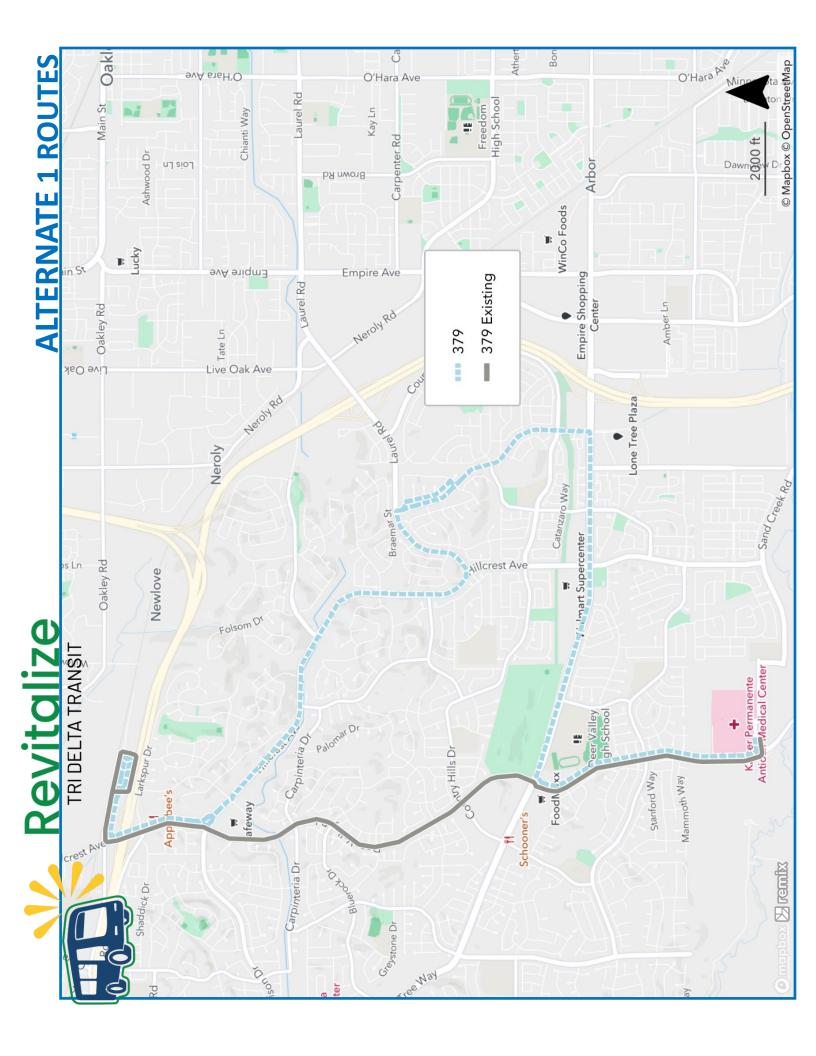




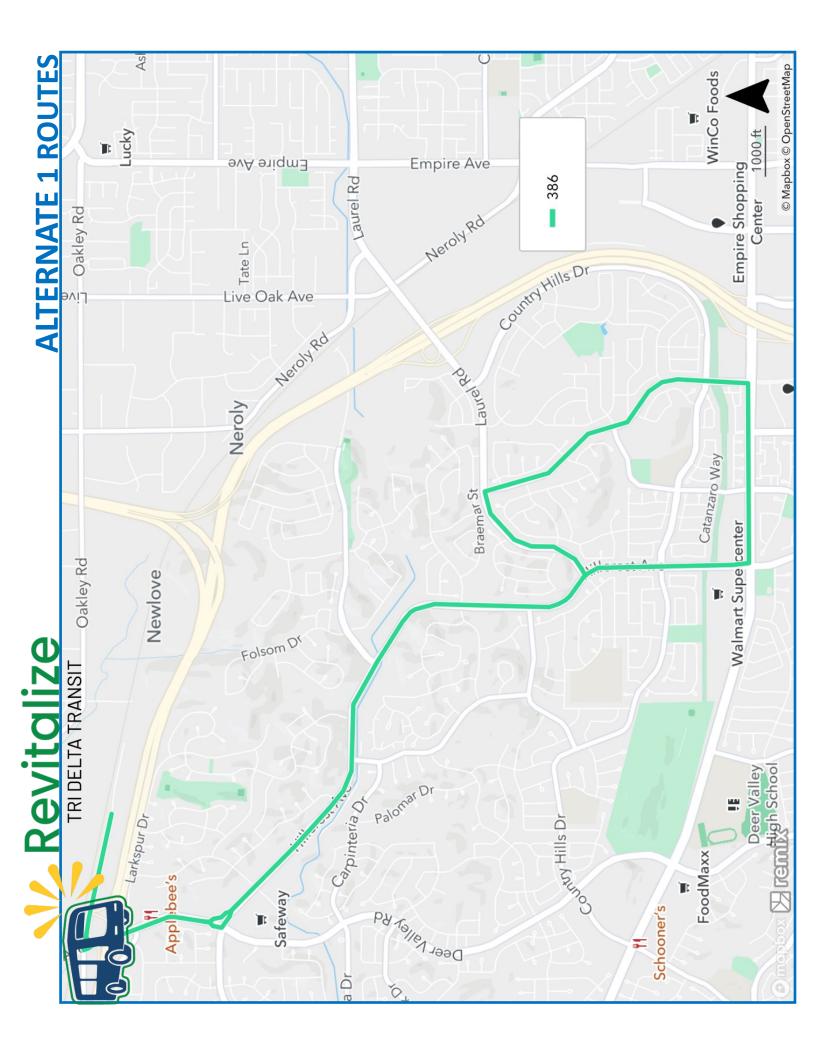

Background

The four Contra Costa County bus operators (AC Transit, County Connection, Tri Delta Transit, and WestCAT), share a non-voting seat on the Contra Costa Transportation Authority (CCTA) Board of Directors. The seat rotates among the four operators in alphabetical order for two one-year terms. Prior to an agency holding the seat for a given term, that same agency holds the alternate seat for the previous two one-year terms.

Discussion

Tri Delta Transit is set to hold the Ex-Officio Alternate seat from February 1, 2025, through January 31, 2026, for the first of two one-year terms. The second one-year Ex-Officio Alternate seat will be held from February 1, 2026, through January 31, 2027. After the Ex-Officio Alternate term for Tri Delta Transit is completed, the Tri Delta Transit seat will then rotate to Ex-Officio for two one-year terms. Completion of Tri Delta Transit's seat on the CCTA board in its entirety will be January 31, 2029.

CCTA bylaws require that all board members; including Ex-Officio members, otherwise be elected officials. The Ex-Officio member does not vote but attends the meetings of the full CCTA Board. The Ex-Officio does not sit on any of the CCTA board standing committees.

The Ex-Officio is to represent all four bus agencies on the CCTA Board.
